 - Student application (duly signed by the student)
 - Proposal of the Institution(duly signed by the Principal)
 - Copy of Matric Roll Number (Self attested)
 - Adhar card (Self attested)
 - Front Page & latest transaction page of Bank Pass book (Self attested)
- For Fresh Student:-
 - Student application (duly signed by the student)
 - Proposal of the Institution(duly signed by the Principal)
 - Copy of Matric Roll Number (Self attested)
 - Adhar card (Self attested)
 - Front Page & latest transaction page of Bank Pass book (Self attested)
 - Fresh Caste Certificate-(Valid by Birth in case of ST/SC and in case of SEBC/OBC valid for last three years from date of issue) (Self attested)
 - Residential Certificate -(Self attested)Valid for five years from the date of issue
 - Income Certificate:-Valid for three years from the date of issue (Self attested)
 - Income declaration of parents/guardian from all the sources on non-judicial stamp paper

Parameter:-

1. Yearly Income for ST/SC:-Not more than 2,50,000.00
2. Yearly Income for OBC/SEBC:-Not more than 1,00,000.00
3. Yearly Income for EBC student (General Category):- Not more than 1,00,000.00, should be studied in Govt. Institution only. Self declaration by the student is sufficient.
4. For OBC /SEBC category student must be secure at least 50% of mark in last exam
5. Bank Account No with IFSC and student name should be matched
6. Adhar Number should be Correct
7. Fresh/Renewal Student
8. Hosteller/Day scholar as per the Inspection Report
9. Matric Roll No, Passing Year, Board should be matched with Matric Board Certificate
10. If there is dot (.) and space () in Name of the Student and it has been locked by both student & college level, then same will be allowed.
11. Category should be matched with Cast certificate, if not matched, then intimate to the office of the DWO,MBJ for temporary rejection through concerned institution
12. If Scheme name is not matching, then immediately intimate to the office of the DWO,MBJ for deactivation his ID (In case of Double ID) .If Single ID, then also inform to DWO,MBJ for permanent rejection, so that the student can apply Freshly. This process should be complied with in 25.11.2018.
13. If Board certificate is of Madhyama (Sanskrit Exam), NIOS, State Open School, then the Board should be OTHERS
